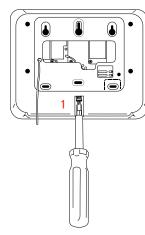
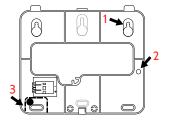
IQ4 NS QUICK GUIDE







1. With a small phillips screwdriver, undo the locking screw from the back of the panel and remove the SmartMount backplate.



- 1. Mount the backplate to the wall using flat head screws* and appropriate wall anchors if needed, ensuring it is level.
- 2. If using the model with the legacy security radio, in the provided hole on the right hand side of the backplate drill a 1/4" hole in the wall and feed the white RF antenna into the wall.
- 3. A screw is required in breakaway wall tamper for UL 2610 and EN Grade 2 installations.

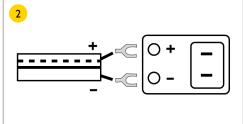


Connect the power supply to the barrel jack on the back of the panel.

- 1. Latch the top of the IQ4 NS onto the SmartMount backplate.
- 2. Swing the panel down towards the backplate and press firmly against the wall.



1. With a small phillips screwdriver, screw in the locking screw from the bottom of the panel to secure it to the wall.



Connect power supply WARNING! Use 7vDC Power Supply ONLY



Press and hold the power button on the right side of the panel for 3 seconds to power up

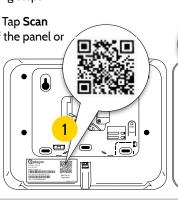

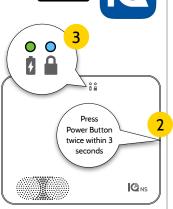
SETUP WIZARD

From your smart device, download "IQ Installer" from the Apple or Google Play stores to connect to IQ4 NS over Wi-Fi to complete local system setup. To connect, complete the following steps:

1. Open the "IQ Installer Interface", tap **Start** on the phone screen to begin. Tap **Scan** QR Code, then position your phone and scan the QR label on the back of the panel or the side of the box. Tap Continue.

- 2. Press the Power Button twice within 3 seconds.
- The **Status LED** will turn solid **Blue**. Tap **Next** on the screen.
- Enter the default Installer (1111) or Dealer (2222) code to connect.
- When prompted, change the default code to a new installer code.
- Select Dashboard, then tap Launch Wizard.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE INSTALLING OR USING THE SOFTWARE EMBEDDED IN OR USED WITH THE HARDWARE PRODUCTS PROVIDED BY GOLSYS ("QOLSYS PRODUCTS") AND ALL OTHER SOFTWARE AND DOCUMENTATION PROVIDED BY GOLSYS WITH OR FOR USE WITH THE ACCOMPANYING GOLSYS PRODUCTS (COLLECTIVELY, THE "SOFTWARE").

THE TERMS AND CONDITIONS OF THIS END USER LICENSE AGREEMENT ("AGREEMENT") GOVERN USE OF THE SOFTWARE PROVIDED BY QOLSYS, INC. ("QOLSYS").

Oolsys is willing to license the Software to you only upon the condition that you accept all the terms contained in this Agreement. If you install or use the Software, then you have indicated that you understand this Agreement and accept all of its terms. If you are accepting the terms of this Agreement on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to the terms of this Agreement, and, in such event, "you" and "your" will refer to that company or other legal entity. If you do not accept all the terms of this Agreement, then Oolsys is unwilling to license the Software to you, and you are not authorized to use the Software. "Documentation" means Oolsys' then current generally available documentation for use and operation of the Software.

- 1. Grant of License. Conditioned upon your compliance with the terms and conditions of this Agreement, Oolsys grants you a revocable non-exclusive, non-transferable and non-sublicensable license to use the Software, solely as embedded in or pre-installed on the Oolsys Products and solely for your non-commercial personal use. Oolsys reserves all rights in the Software not expressly granted to you in this Agreement. As a condition to this license, Oolsys may collect, use and share with its engineering and marketing partners certain information about your Oolsys Products and how they are used.
- 2. Restrictions. Your use of the Software must be in accordance with its Documentation. You will be solely responsible for ensuring your use of the Software is in compliance with all applicable foreign, federal, state and local laws, rules and regulations. Except for any rights provided with respect to included open source software or as expressly specified in this Agreement, you may not (a) copy, modify (including but not limited to adding new features or otherwise making adaptations that alter the functioning of the Software), or create derivative works of the Software; (b) transfer, sublicense, lease, lend, rent or otherwise distribute the Software to any third party; or (c) otherwise use the Software in a way not permitted by the terms of this Agreement. You acknowledge and agree that portions of the Software, including but not limited to the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of Qolsys and its licensors. Accordingly, you agree not to disassemble, decompile or reverse engineer the Software, in whole or in part, or permit or authorize a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition. The Software may be subject to additional restrictions and conditions are hereby incorporated into and made a part of this Agreement. Under no circumstances will Qolsys be liable or responsible for any use, or any results obtained by the use, of the services in conjunction with any services, software, or hardware that are not provided by Qolsys. All such use will be at your sole risk and liability.
- 3. Ownership. The copy of the Software is licensed, not sold. You own the Oolsys Product in which the Software is embedded, but Oolsys and its licensors retain ownership of the copy of the Software itself, including all intellectual property rights therein. The Software is protected by United States copyright law and international treaties. You will not delete or in any manner alter the copyright, trademark, and other proprietary rights notices or markings appearing on the Software as delivered to you. This Agreement does not grant you any rights in connection with any trademarks or service marks of Oolsys, its affiliates or its suppliers.
- 4. Maintenance, Support and Updates. Qolsys is under no obligation to maintain, support or update the Software in any way, or to provide updates or error corrections. However, if any bug fixes, maintenance releases or updates are provided to you by Qolsys, its dealers or a third party, such fixes, releases and updates are and shall be considered "Software", and will be subject to the terms of this Agreement, unless you receive a separate license from Qolsys for that release or update that supersedes this Agreement.
- 5. Subsequent Agreement. Qolsys may also supersede this Agreement with a subsequent Agreement pursuant to providing you with any future component, release, upgrade or other modification or addition to the Software. Similarly, to the extent that the terms of this Agreement conflict with any prior Agreement or other agreement between you and Qolsys regarding the Software, the terms of this Agreement shall prevail.
- 6. Term. The license granted under this Agreement remains in effect for a period of 75 years, unless earlier terminated in accordance with this Agreement. You may terminate the license at any time by destroying all copies of the Software in your possession or control. The license granted under this Agreement will automatically terminate, with or without notice from Qolsys, if you breach any term of this Agreement. In addition, either party may, in its sole discretion, elect to terminate this Agreement on written notice to the other party upon the bankruptcy or insolvency of the other party or upon the bankruptcy or insolvency of the other party upon the commencement of any voluntary or involuntary winding up, or upon the filing of any petition seeking the winding up of the other party. Upon termination or expiration of this Agreement, the license granted in Section will automatically terminate and you must at Qolsys' option, either promptly destroy or return to Qolsys all copies of the Software in your possession or control. On Qolsys' request, you will provide Qolsys with a signed written statement confirming that the Software has been permanently removed from your systems.

NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM QOLSYS OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS AGREEMENT. QOLSYS DOES NOT WARRANT THAT THE SOFTWARE WILL MEET YOUR EXPECTATIONS OR REQUIREMENTS, THAT THE OPERATION OF THE SOFTWARE WILL BE CORRECTED.
- 8. Limitation of Liability. QOLSYS' TOTAL LIABILITY TO YOU FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO \$100. IN NO EVENT WILL QOLSYS BE LIABLE TO YOU FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF PROPERTY OR LOSS OF DATA OR BUSINESS INTERUPTION) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE EXECUTION OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, AND WHETHER OR NOT OOLSYS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. If provided for in the applicable third party license, you may have a right to reverse engineer such software or receive source code for such software for use and distribution in any program that you create, so long as you in turn agree to be bound to the terms of that license, and your programs are distributed under the terms of that license. This Agreement shall not be construed to limit the rights you may otherwise have with respect to the Linux operating system and other third party technology or software licensed under open source or similar license terms. - 12. Confidentiality. You acknowledge that the ideas, methods, techniques, and expressions thereof contained in the Software (collectively, "Oolsys Confidential Information") constitute confidential and proprietary information of Oolsys, the unauthorized use or disclosure of which would be damaging to Oolsys. You agree to hold the Software and Oolsys Confidential Information in strictest confidence, disclosing information only to permitted individual employees who are required to have access in order to perform under this Agreement and to use such information only for the purposes authorized by this Agreement. You are responsible for and agree to take all reasonable precautions, by instruction, agreement or otherwise, to ensure that your employees who are required to have access to such information in the Software and Oolsys Confidential Information are confidential proprietary information belonging to Oolsys and to ensure that they make no unauthorized use or disclosure of such information. You may disclose Oolsys Confidential Information if you are required to do so pursuant to a governmental agency, a court of law or to any other competent authority so long as you provide Oolsys with written notice of such request prior to such disclosure and cooperate with Oolsys to obtain a protective order. Prior to disposing of any media reflecting or on which is stored or placed any Software, you will ensure any Software contained on the media has been securely erased or otherwise destroyed. You recognize and agree a remedy at law for damages will not be adequate to fully compensate Oolsys for the breach of Sections 1, 2, 3 or 12. - 16. General. This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflict of laws rules or principles. You may not assign or transfer this Agreement or any rights granted hereunder, by operation of law or otherwise, without Oolsys prior written consent, and any attempt by you to do so, without such consent, will be void. Oolsys has the right to assign this Agreement unconditionally. Except as expressly set forth in this Agreement, the exercise by either party of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible, and the other provisions will remain in full force and effect.
